

# Program Overview

## About Head Start

Head Start/Early Head Start is a nationwide, federally funded program whose purpose is to promote school readiness by enhancing the social, physical, and cognitive development of children. Head Start was launched in 1965 by President Lyndon B. Johnson to provide comprehensive health, nutrition, and education services to children living in poverty. Over the last 55+ years, more than 37 million children have benefited from Head Start's unique approach, which is built on the premise that every child, regardless of circumstances at birth, has the ability to reach their full potential. Today, Head Start serves more than one million children, families and pregnant women each year on their path to success.

## About MFCS Head Start

Our mission at Mid Florida Community Services, Inc. (MFCS) Head Start/Early Head Start is to provide comprehensive early childhood services that enhance the lives of children and families to collaboratively foster school readiness and self-sufficiency. We provide services in Hernando, Sumter, and Volusia counties of Florida. Our Head Start/Early Head Start programs are based in centers, schools, and within homes of families in our home-based option. The programs provide services at no cost, for infants, toddlers, preschool aged children, and pregnant women.

## Head Start

MFCS Head Start serves children across Hernando, Sumter, and Volusia Counties in center and school based settings. Our Head Start program is funded to serve 977 children. Head Start delivers services at no cost to eligible children ages three to five years old, and their families. Our Head Start program provides comprehensive services in the core areas of early learning, health, and family well-being while engaging parents as partners every step of the way.

Early Head Start provides early, continuous, intensive, and comprehensive child development and family support services to low-income infants and toddlers and their families, and pregnant women and their families. MFCS is the grantee for three Early Head Start grants serving a total of 272 infants and toddlers. Early Head Start I serves 112 children, Early Head Start II serves 120 children, and Early Head Start III serves 40 children.

## Early Head Start

MFCS Early Head Start serves children across Hernando and Volusia Counties. Early Head Start programs provide services to families through a full day, full year program. MFCS provides EHS services in both center based and home-based settings. Both options provide early learning, care and enrichment to our enrolled children.

The Early Head Start Home-Based program is offered in Volusia County. This program services pregnant women and families with children up to age 3. Our Home-Based Program is a continuation of the comprehensive services we offer at MFCS. It is a way to offer support, guidance, information, and child development services directly to children and families within their homes. Home visiting is also unique because it offers an opportunity for families to get the support they want in their own homes weekly.

## Our Services

Our programs support children's growth and development in a positive learning environment through a variety of services. These services include early learning, health, and family well-being through opportunities such as:

- Providing nurturing, responsive, and effective interactions and engaging environments.
- Ensuring frequent medical screenings, immunizations and dental services.
- Healthy nutritional assistance, including free meals & formula for center based options.
- Referral services for a range of individual child and family needs.
- Opportunities for parents to participate in school decision making.
- Diapering & Toilet Training, including free diapers for center based options.

# Making an IMPACT For Parents

We always strive to help our families when they are in need. Recently, our program stepped in to assist one of our Head Start families. One of our Head Start parents, Ashley R. had recently been experiencing tough times and expressed this to her family advocate, Lynda Kersey. Lynda knew something had to be done and reached out to our Health Services Coordinator, De'Lillian to see how we could help. Ashley R. is a single mother of four children. Their ages are 9, 8, 5, and 3. One of her children is a former Head Start student, and one attends our program currently. Our Health Services Coordinator arranged to provide this family with food, diapers, clothing, shoes, and undergarments during the COVID-19 pandemic.

However, the giving doesn't stop there! Our very own MFCS Community Engagement Coordinator, Ashley Hofecker had a community connection with the service manager Jessica at the local SunCoast Credit Union. Jessica informed Ashley Hofecker that they were looking to assist a family in need during the COVID-19 pandemic. Ashley R's family was then selected to receive the assistance. When the hardworking mother who works 2 jobs was asked what she needed, she responded that she didn't need anything personally, but that her children really could use a new bed, and that they had been sleeping on mattresses on the floor. The mother had already looked into purchasing the trundle style bed and had put it on layaway in hopes of paying it off over time. Jessica at SunCoast along with other employees there joined together to raise money for Ashley R's family. They raised \$218, and contacted Big Lots where Ashley R. had put the bed on layaway. The Big Lots manager gave a 20% discount upon learning of this mother's story. After the discount and funds raised by the SunCoast staff, Ashley R. only had to pay a very small amount out of pocket for her children's new bed.

# The Impact We Made During the COVID-19 Pandemic!

During this unprecedented time in 2020, the Mid Florida Community Services, Inc. Head Start/Early Head Start staff ensured that our Head Start and Early Head Start children and families were provided the services we typically offered. We quickly implemented new processes to best serve the children, families, and our staff members. Here are some of the responses we made in relation to the services offered within our program.

## **EDUCATION**

Education: Parents and Guardians could choose for their children to attend the brick and mortar option, or virtually. Each one of our centers hosted online lessons through the Zoom platform for children to participate in. The interactive classroom approach allowed the children to come together in a virtual group setting to see their classmates and their teachers, despite not being able to attend in person.

The education staff also hosted a drive-thru events where parents and guardians could pick up education bags. These bags included curriculum packets, learning materials, and supplies. The children were provided the resources needed, so they could learn and succeed at homes.

The teachers and family advocates presented drive-thru Trunk Edition Meet The Teacher Events. Families drove through the event and saw our staff holding welcome signs and cheering. They saw staff's vehicle trunks decorated by the staff with themes of children's books and authors. Many of the staff members dressed up to go along with their trunk theme. While classroom sizes were limited to ensure social distancing, our staff members innovatively created a safe and welcoming environment for families and children to meet their teachers and family advocates.

## **HEALTH**

Health: Our top priorities was being committed to the health and safety of children, families, and staff. We complied with all Department of Children and Families, Office of Head Start, Centers for Disease Control, and local health department guidelines associated with the COVID-19 pandemic. We created health check tents outside of the centers and continue to use them. Children's temperatures are taken upon arrival and they are unable to enter if the temperature exceeds 100.4. Staff escort children to and from their classrooms and no outside visitors, including parents and guardians are allowed to enter the center. Masks are required. Hand washing is strictly enforced. Meals are served pre-plated and pre-packaged. There is minimal intermixing of children from different classrooms. Social distancing is strongly encouraged. Our staff frequently sanitize, disinfect and clean the classrooms. In addition, our facilities have electrosonic fumigation conducted weekly.

Our program also provided food and meals for our families to pick up in a socially distanced, drive-thru format. If a parent or guardian did not have the ability to pick up the food, our Family Advocates delivered it to them. Our program ensured our children were still getting the proper health and nutrition while not in the classroom setting. In addition, the free supplies that our program provides in the classroom such as diapers, wipes, and formula were made available for families that needed them during this difficult time.





## **Our COVID-19 Impact Continued**

## **FAMILY & COMMUNITY**

Family & Community: Our program focuses on the whole child and their family. The Family Advocates stayed in contact with parents and guardians every step of the way during the pandemic. They provided local resources and information to assist the families with their specific needs. Some of these resources included, community grocery and meal giveaways, unemployment resources, laundry vouchers, housing assistance, mental health resources, and more. They also facilitated virtual parent meetings to keep parents and guardians abreast of all changes and to promote communication for anyone who was experiencing difficulties during the COVID-19 pandemic.

Community resources, learning videos, at home education resources, family engagement ideas, health information and all COVID-19 related resources and information were provided on our company website and social media pages for families to access.

## **OUR STAFF**

Our Staff: Our management team implemented strategies to ensure the well-being of staff. Managers made contact with staff during the closure to inquire how they were doing and to see if they were in need of assistance. In addition, information on mental health resources was made available to all staff members. Our Director of Early Learning Programs, Heidi Rand kept staff informed of all updates regarding the COVID-19 pandemic. This was essential for staff to be aware of all pertinent information so program operations continued to function accordingly.

Every MFCS Head Start/Early Head Start staff member was an integral part of making an immense impact during a time that we had never experienced or could have prepared in advance for. We accommodated our children and families in every way possible to ensure there was no lapse in services, or lack of resources that we could make available to them.

The response our program had during the COVID-19 pandemic was essential to continue our mission of assisting our families in achieving self sufficiency, and providing comprehensive early learning services that foster school-readiness.





## **Health Services**



MFCS Head Start & Early Head Start Health Services would like to highlight our partnership with Premier Dental in Hernando County, our push to provide "Grab & Go Meals" for the children enrolled in our virtual program, and our COVID-19 response.

The Head Start Performance Standards dictate that all children enrolled in the program must have a dental exam within 45 days of entry. In order to achieve this, MFCS HS/EHS and Premier Dental have expanded our partnership to include both centers in Hernando County; Brooksville and Spring Hill. Our partnership with Premier Dental ensued the mobile dental unit parked at our centers for the first three weeks of school. This ensured easy access to a comprehensive dental exam for all enrolled children with parental consent. The mobile dental unit has also been scheduled for a return in late October and early November to complete any oral health follow-ups that are needed and complete any further exams that may be needed.

Since the coronavirus pandemic has changed the capacity of children we serve, the decision was made to offer parents/guardians, of children in our program, the option to attend the program virtually. Since these children are not attending brick and mortar, they do not receive the meals provided in care. To help reduce food insecurities in our families, MFCS decided to provide meals to the children enrolled in the virtual program. MFCS ordered and received shelf stable meals for each "virtual" child in a 5-day meal box. The meal boxes contain 5 days' worth of USDA/CCFP compliant breakfasts and lunches. The families simply make an appointment with their Family Advocate and then are issued a 5-day meal box. We are happy to offer this service to our families.

MFCS HS/EHS has taken a number of steps to prevent the spread of COVID-19 in our brick and mortar centers. We have instituted daily temperature checks for all children and staff. We have capped the capacity of our classrooms at 12. We have discontinued family style dining and tooth brushing activities. We have provided appropriate face masks for all staff and children over age 2. We have instituted policies that ensure a safe distance is maintained as much as possible between adults. We do require face masks when social distancing is not possible.

Mid Florida Community Services Head Start & Early Head Start Health Services continues to strive to provide high-quality comprehensive services that meet the needs of children and families and comply with the Head Start Performance Standards.

## Parent Engagement

Parent Engagement is one of the core values at MFCS Head Start/Early Head Start. We coordinate, promote, and reinforce the importance of parent engagement and participation in the community. Family engagement is supported in multiple settings through the services and resources that we offer. Our staff inspire the children to interact, learn, and play together on various occasions. We invite and encourage families to attend events, visit the classroom, and volunteer at our centers to further promote the importance of family engagement. Our parents have the opportunity to participate in parent committees, monthly parent meetings, planned parent activities, parent trainings, and serve on the policy council throughout the school year. This is beneficial for several reasons. It empowers parents and guardians to assist in making decisions that determine how to best serve children in our program. Parents and quardians get to engage with their child in a classroom setting which shows the children they are interested in their daily routine. It also helps develop fellowship with other parents, and guardians, and learn about what is happening in their child's center.

As we know, these parent engagement activities looked much different this year. We still know the importance of family engagement and involvement in our program. It was especially imperative this year, that families had options and ideas to stay engaged with each other during this unprecedented time.

Here at MFCS Head Start / Early Head Start, we transitioned all parent engagement activities, and policy council meetings to a virtual setting.

We sent home family engagement activity bags to our families, and family engagement resources were added on our website and social media pages. We hosted social media contests for parents and guardians that shared ways they were engaging with their families at home. Our Family Advocates also provided incentives such as raffles for parents and guardians who attended the virtual parent meetings. We had a large participation rate while the meetings were virtual.

In addition The Family Advocates implemented the parent curriculum, "What You Do Matters." This six week series educates parents on four important areas of child development; Language, Social-Emotional, Cognitive, and Motor skills. This comprehensive curriculum connects parents and guardians, helps them to learn together, share their own experiences, and ask questions. They also are given a list of activities that they can do together with their child at home. "What You Do Matters" teaches parents and guardians new ways to interact with their child and help them to successfully learn and grow.

Prior to the COVID-19 pandemic, we hosted in person parent engagement activities. We hosted parent meetings, where parents and guardians created potted plants, and painted beautiful canvases. Spring Hill hosted a Winter Festival full of fun and games. Our Early Head Start Home-Based program held their monthly group socialization event. Some Head Start Children visited the Museum of Art, DeLand where they learned about new art exhibit and created crown hats. Parents and guardians also attended as chaperones for this event.

## **Community Partnership**

Mid Florida Community Services, Inc. Head Start/Early Head Start takes great pride in creating and maintaining community partnerships with a variety of community organizations. Community partnerships help us to fulfill our mission and increase our potential while also assisting in fulfilling the mission of our community partner organization.

This year, we'd like to highlight a community partner that goes above and beyond for the communities they serve. We are appreciative of the vast impact they have within the community. They host community outreach events in which our staff attends and shares valuable information about our programs directly to the residents of the communities we serve. The Daytona Dream Center is a 501C3 non-profit organization. Their mission is to see the community transform. They aim to create a healthy and flourishing community by providing opportunity and personal development for people in need. They strive to link arms with local partners to unlock their full potential. We recognize that Daytona Dream Center fulfills their mission in its entirety.

During the COVID-19 pandemic, the Daytona Dream Center quickly jumped into action to serve Volusia and Flagler residents who were suffering from a lack of resources such as food insecurities. They host a mobile food pantry which meets the needs of people right where they are at. Through their outreach efforts, they hosted 10 mobile food drops during the COVID-19 pandemic. We attended several of these outreach events and were in awe of the turn out, and were so excited to share information about our no cost programs during these difficult times. Through a partnership with Second Harvest Food Bank, the Daytona Dream Center has distributed over 450,000 pounds of food and 8,400 mobile meals to those who could not get to the distribution sites. They made an impact in over 15,000 people's lives.

The Daytona Dream Center also reaches the community in immense ways through their Adopt-A-Block event. At this event their team members, go to a neighborhood in the local community and cleanup, host a block party, provide free groceries, a free meal, and fill the specific needs of the community. In addition to the community events previously mentioned, The Daytona Dream Center in partnership with PayIt4Ward hosted a free drive-thru backpack giveaway. We also attended this event, and saw first hand just how excited the children were to receive their very own backpack loaded with a variety of school supplies.

Each of these events are so impactful and we look forward to attending them, to continue our community outreach efforts, and directly link families in need with the services we offer.

We are so appreciative of the partnership we have with The Daytona Dream Center, and are so thankful for the incredible impact they make in the community, our organization, and people's lives.

# Transitioning to Kindergarten





## The goal of early childhood education should be to activate the child's own natural desire to learn." ~ Maria Montessori

MFCS supports our Head Start children going to Kindergarten in several ways. In late May, all outgoing children are provided with a "Transition Bag". The bag includes items such as developmentally appropriate activities parents can do with their children during the summer, school supply materials for children, a book, healthy food recipes, a registration requirement list from the local public schools, an information booklet for parents to prepare their child for kindergarten, and information about community resources.

During May Parent Committee meetings, kindergarten teachers from the local elementary school or a district kindergarten representative are invited to present important information to parents regarding the kindergarten registration process and kindergarten expectations.

In Volusia County the school district hosts Articulation Meetings and invites Head Start teachers and teachers from local private child care and other VPK programs. These meetings are held at local elementary schools and are hosted by kindergarten teachers. The teachers present an overview of the kindergarten requirements. The Head Start and other early childhood teachers are also provided a tour of a kindergarten class and the kindergarten teachers are available to answer any questions.



Many of the Head Start classrooms work closely with a local elementary school and may take part in the "Adopt a Pre-School" program. This allows for the children of the Head Start classroom to visit a local kindergarten classroom and participate in a portion of the day with the kindergarten children. Many times they are invited to join the kindergarten class for lunch. By this point the Head Start children have been practicing in their own classrooms and have learned how to carry a lunch tray. The Head Start children are very proud when they have the opportunity to participate in a kindergarten day.

MFCS Head Start was a participant in a collaborative effort with a local school district personnel and staff from the local Early Learning Coalition to develop a Kindergarten Readiness checklist. Head Start teachers have the opportunity to complete these checklists on children leaving our Head Start program and entering into kindergarten. They are then provided to the kindergarten teachers at the elementary school where the child will attend kindergarten.
