
Minutes from Parent Meeting February 15, 2023

We had 9 parents in attendance. Items discussed were about children being left in cars when dropping off, and picking up other children. We made sure they are aware that it would be an automatic DCF call as it is dangerous. We spoke about children also needing to placed in a car seat and if they are caught without one it is a hefty fine from the Police. We spoke about some families needing upcoming Shots, and Physicals. We spoke about our kids needing Dental Exams as well. I did let them know that the scan code is on the form so they can find a place to take the children. I let parents know I would be sending forms out today. I explained to families for children who are already 3 or turning 3 before June 2nd they would be aging out of Early Head Start and June 2<sup>nd</sup> is the last day of school for them. I did let them know we needed to get a Head Start Application done. I spoke about children needing Roll Over forms done we would start in April. Mrs. Jennifer Reminded Families about the Event in the Park on March 29th. She explained what it was going to be and let parents know it was an Early Release day. Teachers Report: We let parents know that class 1 was working on different types of Chairs within their class, and are also working on Social Emotional Skills.
