
#### Classroom News

On the Month of September, we are introducing different feelings to the children, Happy, Excited! Sad, and Angry. How to identify them and how to identify our feelings to feel better. The student will draw faces to show their feeling. We are introduced absent child by singing "We Wish You Well and "Welcome Back" when those they are absent came back to school. We are continuing the use of Second Step songs reinforcing the use of Listening rules and calming techniques from Conscious Discipline.

All the children enjoying getting know us better. They enjoy play with other peers, going to different areas. We continue working identify how many peers on each area, cleaning when you are done to move to another transition.

# What should we do if we get sad or scared?

- Feeling Sad
- Show your child one of her dolls or stuffed animals and say, Oh no, I see that (Benny the Bunny) is frowning. He looks sad. What can we do to help him?
- Ask your child what helps her feel better when she feels strong emotions, e.g., asking for help, taking deep breaths, finding a toy that makes her feel better, or sharing how she feels with others.
- Encourage your child to choose a strategy that helps and practice using it with the doll or stuffed animal. You gave Benny a hug. It looks like he feels a little better now.
- ~What strategies did your child share that help her feel better when she is feeling strong emotions?

#### Welcome and Introduction:

Ms. Cassandra welcomed and thanked parents in attendance for coming to the 1st Parent meeting at Woodward Ave. Head Start. The parents that were able to attend virtually and FA thanked them for their time and willingness to participate. Due to technical difficulties, the parent made their responses by text/chat format. Ms. Cassandra thanked them for their willingness to be flexible and patient with our format. The parents in attendance stated that they would like to change meeting time, date and format of meetings. A majority of the parents in attendance stated that they would be open to having the parent meeting between the hours of 2:00 pm and 3:00 pm. The parents in attendance stated that they liked the Virtual meeting format due to the scheduling of other family obligations. Each parents typed in their viewpoint and agreed about the style of meetings. The center meetings will be held virtually on the third Tuesday of each month at 3 PM. The FA stated that she would be willing to send notice of agreed meeting day (ie: Tuesday) and time (ie: 2:30 pm) to the center parents by email. Due to the small number of parents attending the first meeting, Ms. Cassandra explained the process of selecting officers for the center and stated that if anyone is interested in any of the positions—Chairperson, Vice-Chairperson, Secretary, Treasurer, and Policy Council Representative. No positions were selected at this meeting. However, the FA encouraged parents to please reach out to her by the next parent meeting in order to think about being involved with the officers and select the rest of the center representatives. FA stated that she would have a duties list for them to review and encouraged them to become involved in our operation and understanding of Head Start at the center.

FA thanked the parents in attendance for turning in requested health information and other paperwork in a timely fashion and she stated that she will always try to inform them of items that are needed in plenty of time so that their children will not miss out on their time in school. FA stated that she sent out Parent Handbooks by email to those in attendance and encouraged them to read it. Ms. Cassandra gave a brief bio about herself, and invited the staff and parents to introduce themselves. Mrs. Aida and Ms. Katherine gave short bios of themselves. Ms. Pam, Site Supervisor, introduced herself, and stated that she would be available to them if they had any questions.
